In the solution of the initial value problem for plasma oscillations by means of the Laplace transform, the corresponding Ansatz is the Landau prescription for the integration contour in the complex $\omega$-plane to be taken parallel to the real axis with a small positive imaginary part (Fig. 2.7(a)). To determine the asymptotic behaviour for $t \rightarrow \infty$, this contour is to be deformed into the lower half of the $\omega$-plane around the branch points and zeros of the dispersion equation. This yields damped solutions. All this is not specific for the kinetic description but carries over to MHD waves, as outlined in Sections 6.3.2 (Fig. 6.11), 10.3 and 10.4.
